

GENERAL NOTES:

- I. All coordinates shown on this drawing are referenced to the NAD83, 2001 adjustment, Texas State Grid system, South Central Zone as measured by GPS.
- 2. This site lies in Shaded Zone "X", described as an area of 0.2% annual chance flood; areas of 1% annual chance flood with average depths of less than I foot or with drainage areas less than I square mile; and areas protected by levees from 1% annual chance flood, as shown on F.E.M.A. Flood Insurance Rate Map Number 4820IC0855L, dated June 18, 2007.
- 3. Boundary information is shown per the plat of Bintliff Center as recorded in Film Code No. 654082 of the Harris County Map Records. Location of the property is per the coordinates shown on said map. A boundary survey was not performed under this scope. Boundary lines are shown for illustration purposes only.

NOTE: The benchmark has been destroyed. Sidewalk has been replaced. An elevation was taken on thye sidewalk at the spproximate location of the benchmark and a difference of 0.03 was noted between the published elevation and the measured elevation.


