

## Miscellaneous Item I - 1

A total of 297 easements are required from 114 property owners. 125 of the 297 are CenterPoint easements. An additional 20 easements are from Magellan, leaving 152 easements of the 297. All of this remaining group, with very few exceptions, are similar to the Service barn property (in that they are located on existing CenterPoint Right of way). We are actively seeking the remaining easements with 28% unsigned to date.
