Kathlie,

Thank you for your time yesterday afternoon. As we discussed, we have a client that is looking at a site located at the southwest corner of Shepherd and 26th Street. The site is bisected east-west by an existing public 8" sanitary sewer line. We are prepared to go through JRC to reroute the line and we have surveyed manhole depths in the field as we explore possible alignments for the reroute. I have attached an exhibit using GIMs as a base map to show the area we are talking about, subject site, and existing sanitary sewer lines in the vicinity.

As you can see there are no options for a reroute that allow for adequate slope on a proposed line. We would like to propose that we construct a public sanitary sewer lift station on our site to allow for the reroute of the line that currently bisects the site. We are not seeing another option in this case and I would like to get concurrence form the City that this is an acceptable option as quickly as possible. Our client is planning to close on this site Monday of next week but we have to have a clear path forward with regard to how the sanitary sewer reroute would be handled.

If you could please talk with your maintenance group to confirm whether this is an acceptable option we would appreciate it. I am in the office today and tomorrow and I am also available to meet again if we need to in order to finalize this.
