LINE OF DENNIS STREET, 80 FEET WIDE, AS RECORDED UNDER VOL. 55, PG. 222, H.C.D.R., FOR THE EAST CORNER OF LOT 4, BLOCK 32, OF THE FAIR GROUND, MAP OR PLAT THEREOF RECORDED UNDER VOL. 55, PG. 222, H.C.D.R., CONVEYED TO H.A. FRANZ & CO., AS RECORDED UNDER HARRIS COUNTY CLERK FILE (H.C.C.F.) NO. E421490;
