COMMENCING at a found 3/4 inch iron pipe at a fence corner for the North-east corner of the Edward Shipman Survey per Court Decree Cause No. 5839, Eleventh District Court, Harris County, Texas;

THENCE South 00° 48' 13" East with the East line of the Edward Shipman Survey by said court decree, 1975.27 feet to a 5/8 inch rod for corner, being the Southeast corner of Hunterwood Village Subdivision, Section One (1);

THENCE along the arc of a curve to the left, having a chord of South 57° 55' 04" West, 1059.18 feet, a radius of 4,400.00 feet, a central angle of 13° 49' 33", a distance of 1061.75 feet to a point for a corner and the PLACE OF BEGINNING for the tract herein described;

THENCE along the arc of a curve to the left, having a chord of South 34° 00' 23" East, 33.49 feet, a radius of 166.00 feet, a central angle of 11° 34' 43", a distance of 33.55 feet to a point for a corner;

THENCE along the arc of a curve to the right, having a chord of North 53° 05' 22" East, 272.96 feet, a radius of 3865.00 feet, a central angle of 04° 02' 50", a distance of 273.02 feet to a point for a corner;

THENCE North 28° 45' 09" East, 95.05 feet to a point for a corner
