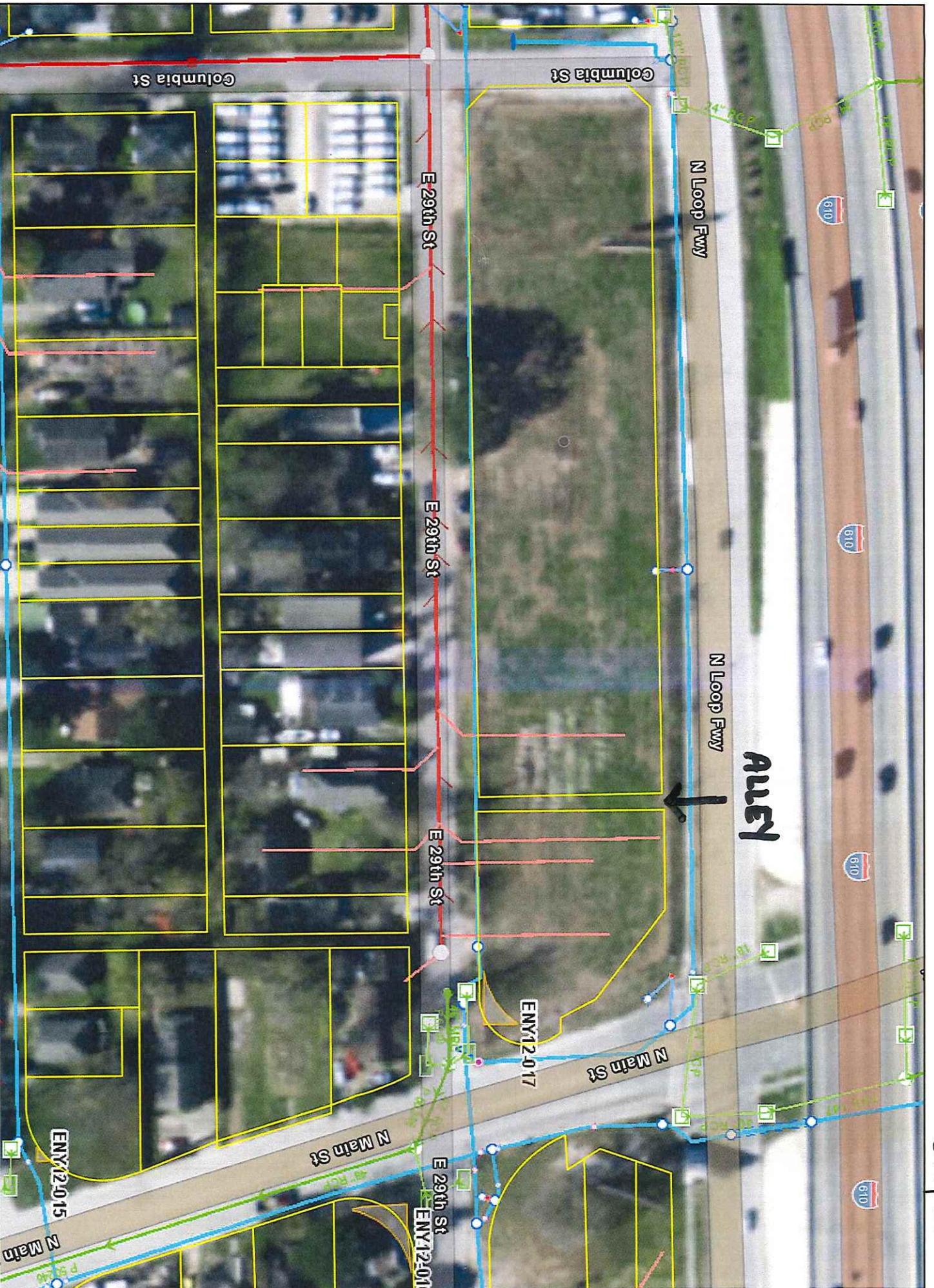


LOCATION MAP

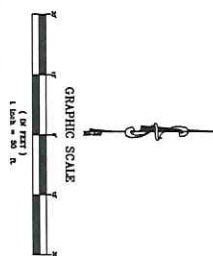
